#### IV. CONSENT AGENDA: ACTION ITEMS

- A. Award the base bid for the 2023 Capital Outlay Project to Murnane Building Contractors, Inc. of Plattsburgh, NY being the lowest responsible bidder in accordance with the recommendation of BCA Architects and Engineers, involving classroom renovations at the Main Building. A total of one (1) bid was received for the single prime contract.
- B. Authorize the Superintendent to execute the Proposal for construction management services from SchoolHouse Construction Services, LLC, to provide construction management services in support of the 2023 Capital Outlay Project.

#### V. PERSONNEL AGENDA

- A. Grant tenure to Samantha O'Hagan, teaching assistant, in the Teaching Assistant tenure area effective September 1, 2023.
- B. Upon recommendation of the Superintendent, appoint Nicholas R. Brindisi, who is professionally certified in the Childhood Education Grades 1-6 area, and who has previously obtained tenure and had an APPR rating of Highly Effective or Effective in the final year of prior tenured service, to the position of Elementary

Teacher for a probationary period commencing on July 1, 2023 and anticipated to end on June 30, 2026. Salary for the 2023-24 school year is \$63,118 in accordance with step 15 B+30 of the collective bargaining agreement.

- C. Upon recommendation of the Superintendent, appoint Saania R. Brindisi, who is professionally certified in the Early Childhood Education birth-grade 2 area, and who has previously obtained tenure and had an APPR rating of Highly Effective or Effective in the final year of prior tenured service, to the position of Elementary Teacher for a probationary period commencing on July 1, 2023 and anticipated to end on June 30, 2026. Salary for the 2023-24 school year is \$61,160 in accordance with step 14 B+30 of the collective bargaining agreement.
- D. Upon recommendation of the Superintendent, appoint Nora A. Canning, who is Initially certified in early & childhood education, to the part-time, at-will position of Intervention Teacher for the 2023-24 school year. Salary for the 2023-24 school year is \$21,048 in accordance with 0.50 of Step 1 of the collective bargaining agreement. This service will not be credited toward tenure.
- E. Upon recommendation of the Superintendent, appoint Bailey Cross, who is initially certified in Earth Science 7-12 area, to the position of Science Teacher in the science teacher tenure area for a probationary period commencing on July 1, 2023 and anticipated to end on June 30, 2027 and he must have completed the requirements for professional certification by that date. Salary for the 2023-24 school year is \$51,866 in accordance with step 8 B+30 of the collective bargaining agreement.
- F. Upon recommendation of the Superintendent, appoint Ryan Fessette, who is professionally certified in Biology 7-12 area and Chemistry 7-12 area, and who has previously obtained tenure and had an APPR rating of Highly Effective or Effective in the final year of prior tenured service, to the position of Science Teacher in the science teacher tenure area for a probationary period commencing on July 1, 2023 and anticipated to end on June 30, 2026. Salary for the 2023-24 school year is \$67,940 in accordance with step 18 B+30 of the collective bargaining agreement.
- G. Upon recommendation of the Superintendent of Schools, appoint Lawrence Baker to the non-competitive Civil Service title of Custodial Worker (Afternoon) for a probationary period of 07/01/2023 to 06/30/2024. Wage for 2023-24 shall be \$15.38 per hour in accordance with the Step 2 of the collective bargaining agreement, pending successful completion of fingerprinting requirements.
- H. Upon recommendation of the Superintendent, appoint Stefanie Lefand, who is Professionally certified in Childhood Education, to the part-time, at-will position of Intervention Teacher for the 2023-24 school year. Salary for the 2023-24 school year is \$30,930.00 in accordance with 0.50 of Step 14-B30 of the collective bargaining agreement. This service will not be credited toward tenure.

- I. Appoint Theda Wilfore as a per diem administrator at the rate of \$55/hour.
