WAIVER AND RELEASE OF LIABILITY

DISCLAIMER: TOWN OF CHAZY AND CHAZY CENTRAL RURAL SCHOOL SHALL NOT BE RESPONSIBLE FOR ANY INJURY (OR LOSS OF PROPERTY) TO ANY PERSON SUFFERED WHILE PLAYING, PRACTICING, OR IN ANY OTHER WAY INVOLVED IN THE TOWN OR SCHOOL PROGRAM FOR ANY REASON WHATSOEVER, INCLUDING ORDINARY NEGLIGENCE ON THE PART OF THE TOWN OF CHAZY OR CHAZY CENTRAL RURAL SCHOOL, ITS AGENTS OR EMPLOYEES.

In consideration of my child's participation, I hereby release and covenant not-to-sue the Town of Chazy, Chazy Central Rural School and any of their employees, instructors, or agents, from any and all present and future claims resulting from ordinary negligence on the part of the Town or others for property damage, personal injury, arising as a result of my child's engaging in or receiving instruction in Town activities or any activities incidental thereto, wherever, whenever, or however the same may occur. I hereby voluntarily waive any and all claims resulting from ordinary negligence, both present and future, that may be made by me, my child or assigns.

Further, I understand that this program involves certain risks, including but not limited to, neck and spinal injuries, injury to virtually all bones, joints, muscles, and internal organs, and that equipment provided for my child's protection may be inadequate to prevent serious injury. I am allowing my child to voluntarily participate in this activity with knowledge of the danger involved and hereby agree to accept any and all inherent risks of property damage, or personal injury, and to be examined and/or treated at the nearest medical facility.

I further agree to indemnify and hold harmless the Town of Chazy and others listed for any and all arising as a result of my child's engaging in or receiving instruction in Town activities incidental thereto, wherever, or however the same may occur.

I understand that this waiver is intended to be as broad and inclusive as permitted by the laws of New York and agree that if any portion is held invalid, the remainder of the waiver will continue in full legal force and effect. I further agree that the venue for any legal proceedings shall be in New York.

I affirm that I am of legal age, the child's legal guardian and am freely signing this agreement. **I have read this form and fully understand that by signing this form, I am giving up legal rights and/or remedies** which may be available to me for the ordinary negligence of the Town of Chazy and any of the parties listed above.
